Submission Requirements

Ads must be submitted electronically. Digital files of ads will be accepted on Mac or Mac-compatible disk, or via e-mail attachment, in the following formats: Adobe's Photoshop (v8.0 or earlier), InDesign (v3.0 or earlier), Illustrator (v11.0 or earlier), or Acrobat (v6.0 or earlier); or QuarkXPress (v6.5 or earlier). For quality purposes, advertisers should include all fonts and images with the files. A hard copy proof or an Adobe Acrobat (.pdf) version of the file must accompany all ads. Files not meeting these specifications will not be accepted, or may be accepted with the understanding that files will be converted to meet the requirements at a cost to the advertiser of \$80/hour (min. 1 hour).
